Leominster's town centre is only a moments walk, offering an excellent range of amenities to include shops, supermarkets, cafes, restaurants and also a train station with regular train services to the nearby cathedral city of Hereford.

An attractive and original canopy porch with a double opening entrance doors open into the lounge/dining room. The good size lounge/dining room has 2 large leaded glazed windows to the front, vinyl floor covering, plenty of power points, wall lighting and ample room for a family size dining table.

From the lounge/dining room a doorway leads into the kitchen. The kitchen has a range of matching working surfaces of base units under of cupboard and drawers and a planned space with plumbing for a washing machine, built into the working surface is a 4 ring gas hob with a stainless steel extractor hood with light over and an electric oven under. The kitchen has eye-level cupboards, space for an upright fridge

freezer and windows looking back into the lounge/dining room. Also situated in the kitchen is a gas fired combination boiler, heating hot water and radiators as listed.

From the lounge/dining room a door opens into bedroom one.

Bedroom one is a good size double bedroom has ample room for bedroom furniture, wall lighting, vinyl floor covering and a double glazed window to side.

From the lounge/dining room a door opens into the bathroom.

The modern fitted bathroom has a suite in white to include a side panelled bath with a mains fed shower over and a shower screen, low flush W.C. and a wash hand basin with vanity unit under. The bathroom also has tiled flooring, tiled splashbacks and an extractor fan.

OUTSIDE.

Occupants of the of The Old Malt House have use of a bike shed and drying area.

SERVICES,

All mains services are connected and gas fired central heating via a combination boiler system.

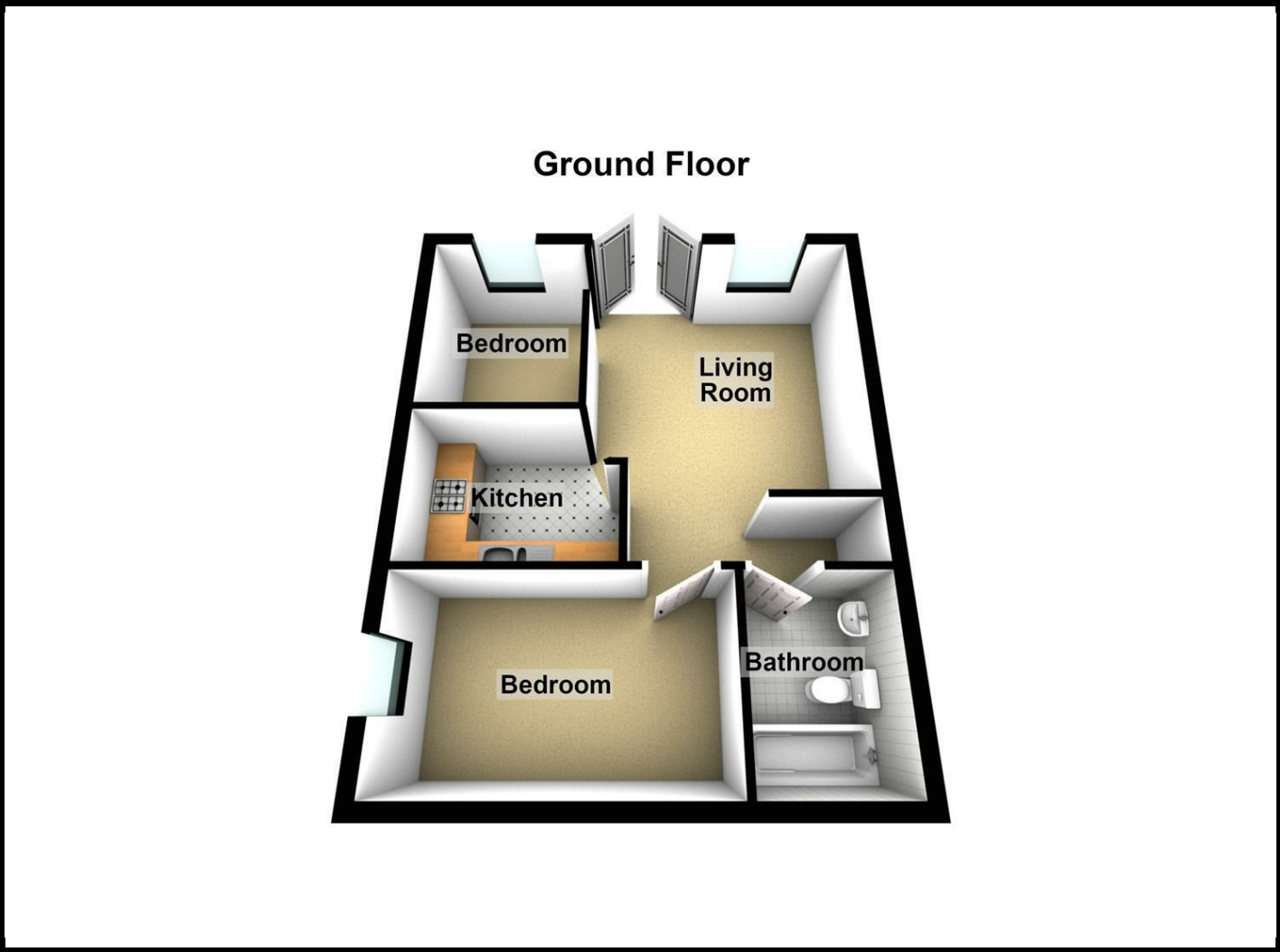
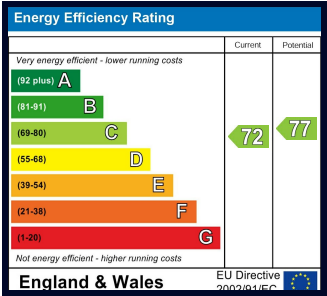
